AWIS accounts are in a healthy state, with more than \$16,000 in the current account and \$25,000 in the term deposit.

Income from subscriptions has increased, as is typical in a conference year. The conference has also generated a good profit which will be reinvested into AWIS activities over the next few years.

Whilst expenditure looks high, this is due mainly to the reallocation of funds raised for the Hidden Figures scholarship into a separate term deposit. This will be invested via the New Horizons for Women Trust, who are managing the scholarship on AWIS' behalf.

As a note of reference, we recognise the passing of our Treasurer and dear friend Hazel Gatehouse in late 2017. As a result, we had several issues over the year organising our accounts and finances, and apologise to anyone who has been impacted by this.
